



## Financial Assistance | Assessment of Need

As with all YMCA Calgary programs and services, financial assistance is available to those who need it through YMCA Calgary's Let's Raise Fund. The following form should be filled out by the parents/guardians of each participant requiring financial support for their program. Assessment of need is to be completed by the group leader/coordinator for each participant and is to remain confidential.

There are three options for accessing the Let's Raise Subsidy Fund. There is a fourth option for families who want to donate to the Let's Raise fund to support another student to attend Outdoor School.

- **Option 1: Automatically Qualify for Subsidy**
  - Are you already enrolled in one of these programs: AISH, Income Support, Social Assistance, City of Calgary fee assistance card, ACHB (Alberta Child Health Benefits), AAHB (Alberta Adult Health Benefits) or Senior Benefits? If so, please check the appropriate box on the application form, provide a copy of your document and pay the school 30% of the cost of the program.
  
- **Option 2: YMCA Calgary Fee Assistance Chart**
  - If you do not already participate in one of the programs listed above, use the chart on the next page to determine an appropriate amount to pay for the program. Please provide a copy of your most recent Notice of Assessment.
  
- **Option 3: Pay what you can**
  - The Outdoor Education department at Camp Chief Hector YMCA recognizes that the above options will not necessarily anticipate or accurately reflect every family's financial situation. If 30% of the fee is not manageable, you can choose to pay what you can. Please indicate what amount you can contribute on the form. Let's Raise will subsidize the remaining fee. Please provide a copy of your most recent Notice of Assessment.



Please note:

- We ask that all families contribute what they can to their child’s experience, no matter what the amount.
- It is acceptable for the school, organization, parent council or a fundraising initiative to contribute additional funds on behalf of a participant.
- Fees are subject to 5% GST which will be added to the group’s final invoice.
